

## FIREBUG One (1) Year Limited Manufacturer Warranty

Subject to the terms and conditions of this warranty, Firebug extends a one-year warranty against any and all defects in material and workmanship to the Original Purchaser (Purchaser) of our Firebug brand product (Product). This warranty is valid from date of purchase.

Invoice clearly indicating date of purchase must be supplied to process warranty claim.

**What Firebug will do:** Upon return of the defective Product to Firebug, Firebug's sole obligation, at its option, is to either repair or replace the Product, or refund the original purchase price in exchange for the Product.

**Purchaser:** This warranty only applies to the Original Purchaser of Products. This warranty is not transferable.

**What is not covered:** the provisions of this limited Warranty do not cover the following costs, expenses and damages:

- (i) Labour costs including, but not limited to, such costs as the removal and reinstallation of Product
- (ii) Shipping and freight expenses required to return Product to Firebug
- (iii) Any other incidental, consequential, indirect, special and/or punitive damages, whether based on contract, warranty, tort (including, but not limited to, strict liability or negligence), patent infringement, or otherwise, even if advised of the possibility of such damages. Some local laws do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusion or limitation may not apply to you.

**The provisions of this warranty do not apply to Products:**

- (i) Used for purposes for which they are not designed or intended
- (ii) Which have been subjected to alteration, abuse, misuse, negligence or accident
- (iii) Which have been improperly stored, installed, maintained or operated
- (iv) Which have been used in violation of written instructions provided by Firebug
- (v) Which, based on Firebug's examination, do not disclose to Firebug's satisfaction non-conformance to the warranty.

**Additional terms:** Firebug does not authorize any person to create for it any obligation or liability in connection with the Product. Firebug's maximum liability here under is limited to the original purchase price of the Product. No action arising out of any claimed breach of this warranty by Firebug may be brought by the Purchaser more than one (1) year after the cause of action has arisen.

**How local law applies:** This warranty gives you specific legal rights, and you may also have other rights as otherwise permitted by law. Refer to your local laws for your specific rights under this warranty.
